CALIFORNIANS FOR BALANCED ENERGY SOLUTIONS (C4BES) RESPONSE TO SIERRA CLUB'S MOTION TO DENY PARTY STATUS TO CALIFORNIANS FOR BALANCED ENERGY SOLUTIONS OR, IN THE ALTERNATIVE, TO GRANT MOTION TO COMPEL DISCOVERY

I. INTRODUCTION

In response to the Sierra Club's motion to deny party status to Californians for Balanced Energy Solutions (C4BES), we submit the following comments.

In its motion for denial of party status, Sierra Club claims that C4BES failed to "fully disclose the persons or entities in whose behalf the filing, appearance or motion is made, and the interest of such persons or entities in the proceeding pursuant to CPUC Rule 1.4(b)(1)." Sierra Club's motion is based on a fiction created by their attorneys to depict the C4BES organization in improper light and to quash a voice that may be alternative to theirs in an administrative proceeding. The motion for party status filed by C4BES clearly stated the entity on whose behalf it was filing (C4BES), and the interest of the organization. As noted, the organization is nonprofit organization that "is a coalition of natural and renewable natural gas users. Our goal is to educate Californians about the importance of natural and renewable gas for improving the environment and providing for a strong economy. We support balanced energy policies that fight climate change while protecting energy choice, reliability and affordability." (p. 2, C4BES Motion for Party Status)

The formation of C4BES was the culmination of multiple individuals and entities coming together to form an organization with a specific and shared goal to educate Californians about natural and renewable gas and support balanced energy policies that recognize the importance of gas for our economy and a cleaner environment. As further described herein, it was initiated by shared ideals, which culminated into a combined effort to develop the organization. C4BES is an independent non-profit organization (501c4)

that was incorporated in January, 2019. Sierra Club alleges that because Southern California Gas Company (SoCal Gas) is represented on the Board of Directors and has been involved (along with many other individuals/organizations from a variety of sectors)¹ in the creation of C4BES, in their estimation, C4BES must be an organization solely controlled by and serving the sole interest of SoCalGas. This allegation is not only erroneous, inflammatory, and unsupported by the facts—it also diminishes the efforts of the community, governmental and business leaders that have worked together to create C4BES.

The Sierra Club began its motion by stating that *"The role of intervening parties is to provide perspectives independent of the utilities the Commission is charged with regulating."* The perspectives of our board members and the hundreds of individuals and businesses that are members of C4BES are independent. While they happen to coincide with many of SoCalGas's perspectives about the need for natural gas and renewable natural gas as part of the equation in fighting climate change and fueling the economy, their concerns extend beyond this. The coincidence of some perspectives with SoCalGas' does not render all of their concerns invalid or their purpose corrupt. C4BES and its members do not accept the idea that complete electrification *in isolation of any other energy sources* is the only environmentally or economically prudent solution. C4BES merely wishes to have this message heard—something that Sierra Club seeks to stifle.

For the reasons provided herein, C4BES respectfully requests the denial of the Motion to Deny Party Status.

II. DISCUSSION

A. <u>The Mere Fact of SoCal Gas's Involvement in C4BES is Not Sufficient</u> to Deny Party Status.

The Commission's Rules of Practice and Procedure require a person seeking party status by motion to "fully disclose the persons or entities in whose behalf the filing, appearance or motion is made, and the interest of such persons or entities in the proceeding." And C4BES did just that. The Motion for Party Status was made on behalf of the C4BES Board of Directors, not on behalf of each or one of the entities and gas users they represent.

The Sierra Club claims it fatal to party status that C4BES did not mention that SoCalGas is a Board member of the organization; however, it does not mention that C4BES also did provide the 29 other board members of the organization. It will do so here:

These names are publicly available on the C4BES website but were ignored by Sierra Club. C4BES and its diverse board members is an independent organization and can properly apply for party status as such. C4BES provides a collective perspective, education, and advocacy of balanced energy solutions; it does not represent the specific or unique interests of any of its individual Board Member or others that have chosen to participate.

Sierra Club used the fiction of three supposed "facts"--each of which is erroneous and inflammatory-- to suggest that C4BES represents no interests other than SoCalGas'. In fact, it is Sierra Club that is "extraordinarily deceptive" in its claims. It looked only for information that supported its story and with this scant information, the Sierra Club sought to create a story that simply did not match the reality. Sierra Club relied on only a few documents that do not impugn or cast serious doubt as to the actual motivations of why this coalition was formed and why such diverse stakeholders have joined and supported these efforts. Involvement by SoCal Gas *and the other members* is not only part of the public record and easily obtained. These individuals and organizations helped in shaping C4BES and continue do so.

1. SoCalGas Was Not Primarily Responsible for Founding C4BES

Despite the Sierra Club's groundless assertions and suppositions to the contrary, C4BES is actually the culmination of many years of independent research, education, and discussion on the topic of balanced energy led by Dr. Matt Rahn. The concept of balanced energy is not new, and was in fact a perennial part of courses, lectures, and workshops conducted by Dr. Rahn since the inception of the environmental programs he directs *dating back nearly a decade*. Those courses and lectures have always addressed a balanced approach to energy, and provided students and the public with information and discussion on traditional energy sources (e.g. oil and natural gas), renewable energy (e.g. solar, geothermal, and wind), nuclear energy, and emerging technologies (e.g. hydrogen fuel cells, renewable natural gas, and battery storage). These courses and lectures were regularly attended by individuals from industry, chambers of commerce, environmental groups, governments, water and utility districts, educators and private citizens.

The original concept for C4BES arose at an Air Quality Summit held in Riverside in early 2017, where the conversation on balance in energy was core to the principles and policies discussed by a diverse group of individuals and organizations.² It wasn't until almost a year later that the concept for C4BES as we know it today was fully conceptualized.

Development of the organization and recruitment of members to the Board was based on discussions among a wide array of key stakeholders and not "limited solely to SoCal Gas" as Sierra Club alleges. The final model of C4BES was eventually formalized in the fall of 2018 in response to continued discussions between key stakeholders, including Dr. Rahn, SoCal Gas, and many others. As a result, Articles of Incorporation were filed with the California Secretary of State by Dr. Rahn in January 2019 to create the entity.³

Shortly after the Articles of Incorporation were accepted, Dr. Rahn hosted the first Board meeting for C4BES on February 28, 2019 where membership, structure, staff, and responsibilities were formalized. The following month, a press release was issued officially announcing the formation of C4BES, that included quotes from Dr. Rahn (as the new Chairman of the Board) and three other individuals on the Board of Directors (Hyepin Im, CEO of the non-profit organization Faith and Community Empowerment; Paul Granillo, CEO of the Inland Empire Economic Partnership; and John Hakel, executive director of the Southern California Partnership for Jobs), further demonstrating collaboration, diversity, and unique perspectives.⁴ Since the organization has been formed, each Board Member including SoCalGas, has had equal weight in terms of organizational decision-making. No single individual or entity has exclusive control of the operations, management, or finances of the organization.

2. SoCalGas <u>Did Not</u> Solely Develop the Organizational Policy Principles for C4BES

Understandably, the C4BES Core Principles represent the gas <u>users' viewpoints</u> and their interest in maintaining the ability to continue using natural gas and recycled natural gas. While these concepts are aligned with SoCalGas' interest, as one might expect, they nonetheless represent a unique and separate voice in this proceeding. Industrial, commercial and residential users are represented on C4BES' Board and each should have the right to voice their collective concerns through C4BES, as a Party, separate and apart from SoCalGas.

So how was SoCalGas involved? Ken Chawkins, is an assistant for SoCalGas' Regional Vice President for External Affairs and Environmental Policy George Minter, who also sits on the C4BES Board of Directors. It is not uncommon for staff to support executives in their community work, particularly with a startup nonprofit organization without a significant staff. Resources by board members are often brought to assist the organization. In this case, Mr. Chawkins worked with others in providing C4BES with PowerPoint drafts as well as compositional and editorial guidance on some of the

formative documents for the organization on behalf of Mr. Minter. Board Chairman Dr. Rahn, a University professor and city councilman, relied on Mr. Chawkins and others as he too has similar commitments and community responsibilities, but lacked the ability or staffing to support this private endeavor. Dr. Rahn also drafted and edited the language for the website, Core Principles, drafts for the initial C4BES board meeting, and other materials, relying on Mr. Chawkins to incorporate all edits and additions, including those by other C4BES board members. These edits were provided to all members, who were given equal opportunity to provide input to C4BES activities.

The Sierra Club erroneously alleges that this logistical and administrative support provided by SoCal Gas is a proxy for having dictating the terms of the newly formed organization, C4BES. It did not. The scant evidence they provide in fact supports that this organization was created in a collaborative way, with leadership provided by key individuals including Dr. Rahn. It was thanks to their early involvement, volunteered time, and dedication to fostering a fair and balanced dialogue that C4BES ultimately emerged.

The assistance of Imprenta Communications in the production of materials was also raised by Sierra Club as apparently beyond the connections of the C4BES. These communications experts are highly respected in public relations and communications, with many clients, including SoCal Gas. They were not unknown to the many leaders on the Board of Directors and provided service to C4BES prior to the organization being incorporated and Board Membership formalized. It was important to Dr. Rahn and other founding members that C4BES be considered an authentic and professional organization, and a successful launch relies on professional services, presentation materials, and other documents. Their support and development of materials was completed in collaboration with Dr. Rahn and other Board Members, not at the sole direction of SoCal Gas. Again, the assertion by the Sierra Club that these consultants were solely responsible for the development of the materials is simply not true.

3. SoCal Gas <u>Did Not</u> Substantially Compensate at Least One C4BES Board Member After he Agreed to Join The Organization.

Perhaps most egregiously, the Sierra Club produced a Twitter post from Randon Lane, a SoCal Gas employee who presented the Environmental Leadership Academy (ELA) with a check for \$25,000 in support of the <u>ELA</u> (on October 17, 2018). The ELA is an annual forum created through California State University San Marcos and supported by multiple education, industry and governmental groups to provide professionals in all circles perspectives on environmental matters that they face. Dr. Rahn is the coordinator of the ELA lecture series and field presentations. The check was a showing of support for the CSUSM ELA Program and was <u>not</u> payment to Dr. Rahn, or any other individual. It went to the university.

The Sierra Club asserts that the timing of this check delivered to Dr. Rahn was a result of his joining C4BES. This is factually incorrect for several reasons, most of which could have been simply resolved had the Sierra Club conducted their basic due diligence, rather than engage in a campaign to undermine C4BES and the credibility of individual members and suggesting that SoCal Gas has "bribed" or compensated members.

First, as described above, Dr. Rahn <u>did not</u> receive compensation in order to gain his membership in C4BES. This is simply not possible since C4BES did not even exist until the following year, and because Dr. Rahn was the individual who actually later filed the Articles of Incorporation with the California Secretary of State.

Second, the funding provided by SoCal Gas was not a personal check written to Dr. Rahn, nor was it a result of any activity related to C4BES. The check was provided to California State University San Marcos (CSUSM). Dr. Rahn was invited to accept the check on the University's behalf. As the Sierra Club rightly asserts, and we have confirmed in this response, C4BES as an organization was not fully contemplated until October of 2018. The check that the Sierra Club uses as evidence is actually <u>part of an</u> <u>ongoing competitive grant program that first supported the Environmental Leadership</u>

<u>Academy (ELA) at CSUSM in 2012</u>. Since that time, SoCal Gas has provided grant support to the ELA program. None of the support for the ELA provided by SoCal Gas at any time is in response to C4BES being formed—there is simply no connection. Further, in 2018, the check that was received was part of a continuing request for support from ELA that was originally submitted to SoCal Gas on July 9, 2018.⁵ Temporally, the Sierra Club story does not match the facts.

Third, and likely most important, the use of the funding received by CSUSM <u>is not</u> <u>directed by Dr. Rahn</u>. The CSUSM Associate Dean for the program is the one who dictates how those funds are expended for conducting the Environmental Leadership Academy. There are numerous safeguards, policies, and regulations in place to ensure ethical standards of funding and remove any suggestion of conflicts of interest.

Funding provided by SoCal Gas is used to help offset the cost of tuition for municipal governments, non-profits, and students. In fact, Sierra Club members and employees have been regular participants in the ELA, and the competitive grant funds provided by organizations like SoCal Gas are used to offset the costs of offering the ELA, providing reduced tuition to nonprofit organizations and even full scholarships to representatives and leadership of the local chapter of the Sierra club itself.

Finally, SoCal Gas is not the only organization that provides grant funding to the University or the ELA. While the Sierra Club is clearly on the side of electrification, they wrongly assert that the funding provided by SoCal Gas proves influence and involvement in C4BES among all members of the board. This is simply not true. Since its inception, the ELA has also been supported by Southern California Edison, as well as water agencies, regional councils of government, education programs, hospital foundations, waste companies, development companies, air quality management districts, fire agencies, banks, and many others.⁶ To assert that Dr. Rahn or the

associated academic programs are influenced by funding is not only an unfounded accusation, but dangerously alleges collusion by the State of California and multiple layers of academic professionals. Universities throughout the United States receive funding from charitable organizations, private donors, foundations, agencies, and other organizations without suggesting undue influence or bribery.

4. The Sierra Club Failed to Acknowledge its Significant and Long-Term Partnership With Dr. Rahn and Associated Education Programs

In its "investigation" leading up to its motion, the Sierra Club worked in concert with other organizations to conduct public records requests of all the emails of several public agency-based C4BES Board Members who are subject to such requests, including Dr. Rahn. Records requests of Dr. Rahn's State (CSUSM), City (Council Member, City of Temecula), and personal emails resulted in only a few documents that simply do not impugn or cast doubt on the motivations of the coalition and why such diverse stakeholders have joined and supported these efforts. The reason why the information the Sierra Club gathered is "limited" is simply because there is no wrongdoing by Board Members, the Executive Director, or any other parties who have participated in the creation of C4BES.

The Sierra Club's inability to believe that independent, diverse, and respected individuals would engage in an organization that promotes the idea of balanced energy is unfortunate, but does not mean that a valid organization does not, in fact, exist. Creating a narrative that suggests collusion, bribery, and complicity is not only an uncharitable fabrication of facts, but may be an intentional misrepresentation of evidence and (depending on the Sierra Club's intent), a violation of Rule 1.1 (Ethics) in misleading the Commission or its staff by an artifice or false statement of fact or law.

It is worth noting that the Sierra Club has significant and intimate knowledge of the programs run by Dr. Rahn, and has been an active and significant partner in those programs and a direct beneficiary of the funding provided by SoCal Gas and other

organizations for many years. Had the Sierra Club conducted their "investigation" into their own files, they would have discovered that their own organization (Sierra Club local chapter, Santa Margarita Group) has had a long history with the parties accused of wrong doing, and have in fact been regular partners, contributors, and beneficiaries to Dr. Rahn and the programs they are condemning. The Sierra Club partnered with Dr. Rahn as recently as 2016, inviting him as a guest speaker to their meetings.⁷ The Sierra Club also partnered with Dr. Rahn and the ELA to provide a team-taught course on Environmental Leadership to local teachers in the Temecula Valley that same year. They worked closely with Dr. Rahn and the University to develop the curricula, provide expert lectures, and provide continuing education units through CSUSM.^{8,9} More recently, the Sierra Club invited Dr. Rahn to speak at the Sierra Club's Santa Margarita Group 10th anniversary celebration, recognizing his support as one of the founding members a decade earlier (January 10, 2018).¹⁰

It is extremely disturbing that the Sierra Club turns so viciously against its own partners and neglected to mention any of these facts in their motion. Instead, they either intentionally or carelessly omitted any past connections to Dr. Rahn in favor of telling a wholly untruthful story simply because he does not agree with their policy of complete electrification in California, and instead prefers a more balanced approach to our energy and climate problem – something that has been a core foundation of his research and education programs for over two decades.

5. The Alignment of Like Ideals Between an Industry Group and a Nonprofit Organization is Neither Unusual nor Condemning of Either.

It is not unusual for environmental or consumer groups to work <u>with</u> industry to promote the groups' larger message. In fact, the Sierra Club recently announced its own collaboration with a specific solar entity, that provides funds to the Sierra Club in exchange for each residential solar facility provided under the program. (See Attachment J; <u>https://cleantechnica.com/2019/03/13/sunpower-sierra-club-to-partneron-residential-solar-incentive-program/</u>) Total electrification of the State would certainly provide a positive impact for the benefits received through this relationship. Under the premise offered by the Sierra Club's counsel in its motion to deny party status—that if industry supports a like-minded nonprofit organization it must be controlled by that industry--Sierra Club could be called a solar industry shill that seeks to enhance its own coffers through CPUC programs mandating increased use of solar over more balanced energy opportunities. Quite to the alternative, C4BES suggests that such industry/nonprofit relationships are commonplace and do not contaminate the purpose of the nonprofit organization.

B. <u>The Commission Should Deny the Sierra Club's Motion to Compel</u> <u>Discovery from C4BES and SoCalGas.</u>

Despite C4BES telling the Sierra Club that none of these issues are valid, they are now seeking discovery to compel the organization to provide more information that they dream would support their conspiracy theories, despite the fact that their <u>assertions in</u> their motion are wholly unfounded and misleading.

The Sierra Club asserts that transparency regarding C4BES is critical. C4BES has been transparent in its intentions, participation, and representation of the independent individuals and organizations that are involved in its creation and continued direction. In fact, they have already had to endure multiple public records act request to provide fodder for the Sierra Club storytelling. SoCal Gas does not exert influence over C4BES, nor do they have control over financial, operational, or administrative functions more than any other single board member does. The selective sharing of information obtained by the Sierra Club failed to acknowledge that in the first Board meeting, C4BES discussed potential budgets, costs, commitments, and potential involvement in the CPUC hearings. SoCal Gas is one of five organizations that have currently contributed funds to help support C4BES; their contributions do not represent a majority of the funds that have been received. SoCal Gas' is just one of thirty voices on the Board. They exert no more influence over C4BES than any other organization or individual.

The Sierra Club motion has extended its witch-hunt far beyond SoCal Gas, and has made very bold and unsubstantiated claims that every member involved in C4BES should be under suspicion, is complicit in a larger conspiracy and that despite these respected organizations having a valid and collective perspective, the intervenor process is being jeopardized. The fictional story should be rejected.

III. <u>CONCLUSION</u>

For the reasons set forth above, C4BES and its Board Members¹¹ respectively requests that the Motion to Deny Party Status to Californians for Balanced Energy Solutions is denied, and that the Commission denies the Sierra Club's Motion to Compel Discovery.

Says Efforts to Eliminate Natural and Renewable Gas in Favor of Electricity Will Harm the Environment and Economy

LOS ANGELES—To most effectively combat climate change, a newly formed organization of natural and renewable gas users and suppliers today called on the State of California to adopt balanced energy policies that protect energy affordability, reliability, and choice.

Formed to educate Californians about the important roles natural and renewable gas play in improving the environment and providing for a strong economy, Californians for Balanced Energy Solutions (C4BES) is a diverse coalition representing a range of commercial, industrial, and residential interests. Its membership includes commercial and industrial gas users, housing developers, community organizations, schools, agriculture, and labor—all of whom rely on gas energy and seek to continue to rely on gas while still making a difference in the state's environment.

"To fight climate change we need a balanced energy portfolio of electricity and natural gas and renewable sources: solar, wind, hydro, and gas derived from landfills, waste treatment plants, and agriculture. Calls to eliminate natural and renewable gas and force Californians to rely only on electric energy are well-meaning but misguided" said C4BES Board of Directors Chair Dr. Matt Rahn, Director of the Environmental Leadership Institute at Cal State University San Marcos and Temecula City Council member. "If successful, the "electric-only" strategy will harm the environment. It will have serious economic consequences because switching to electric power is not technically feasible or cost effective for every use or circumstance."

Hyepin Im, CEO of the non-profit organization Faith and Community Empowerment, noted: "Most households use both gas and electricity. Mandating an energy monopoly will inevitably lead to higher monthly bills creating more burdens on low income households."

"Today, businesses enjoy the ability to choose the energy best suited to a particular need. Relying on a single energy source will jeopardize energy reliability and discourage business investments," said C4BES Vice Chairman Paul Granillo, CEO of the Inland Empire Economic Partnership. Added C4BES board member John Hakel, executive director of the Southern California Partnership for Jobs, "Businesses and industry will be forced to raise prices to pay for costly electricity or leave the state, thereby jeopardizing thousands of jobs. We can fight climate change without endangering California's workers."

"Let's not ban natural and renewable gas. Let's use them to reduce air pollution and fight climate change," said C4BES Treasurer Gretchen Gutierrez, CEO of the Desert Valley Builders Association. "For example, a study by Navigant Consulting demonstrated that replacing 20% of natural gas with renewable gas will produce the same emissions reductions as the conversion of all buildings to electric-only power. It makes no sense not to use natural gas and renewable gas when they are the cleanest and most affordable options available to reduce air pollution and fight climate change."

The nonprofit, 501c4 organization has filed its articles of incorporation with the California Secretary of State's office so as to engage in advocacy efforts. In addition to getting its message out through its website, <u>www.c4bes.org</u>, the organization intends to undertake an aggressive social media campaign, including online petitions and polls, and advertising in newspapers. C4BES also plans to hold a conference on balanced energy policies later this year.

C4BES has set an ambitious agenda, including potentially supporting legislation. The leadership team is strongly committed to calling attention to the vital part played by natural and renewable gas in California's energy portfolio.

"We want to reduce emissions and air pollution while maintaining California's strong economy," said Rahn. "We believe balanced energy solutions are essential for our environment, our economy, and our daily lives."
